Dear Auction Bidder,

Hess Auctioneers offers an Absentee/Phone Bidding Service to bidders who are not present at our auctions. Please note the following procedures for this bidding process:

1. Bidder completes and submits the attached form and Bank Letter of Credit no later than 2 days prior to auction date.
2. Hess Auctioneers confirms bank information.
3. Hess Auctioneers will fax a completed Bidder Form to be signed by Bidder and returned prior to auction day.
4. A representative from Hess Auctioneers will call the bidder's designated phone number on auction day when the noted item(s) are being sold.
5. For each item that the bidder wins the high bid, Hess Auctioneers will charge to bidder's credit card: \$1000 or the purchase price of the item, whichever is less.
6. The bidder **MUST** wire the funds for the remaining balance **PLUS** a 2% Absentee Bidder Fee and Buyer's Premium as listed below within 1 business day of the auction.
7. Pickup times for purchased items are:
  - a. **Auction Day: Friday, February 24<sup>th</sup>, until 5 pm**
  - b. **Saturday, February 25<sup>th</sup>, 8 am to 12 pm**
  - c. **Monday, February 27<sup>th</sup>, 9 am to 3 pm**
  - d. **Tuesday, February 28<sup>th</sup>, 9 am to 3 pm.**
  - e. **NO PICK-UPS ON SUNDAY, February 26<sup>th</sup>**
