Picture Guidelines: (Remember, a good quality picture will attract interested buyers!)

1. If at all possible, move the unit outside and away from other vehicles/buildings
2. **Always hold camera or phone **horizontally (landscape)** not vertically**
3. Be sure camera is set to take pictures in a 4:3 dimension ratio (640x480 or 1600x1200)
4. Take a good, clear picture of the Front Drivers Side (angled) and submit to sales@hessauctioneers.com by the **Brochure Deadline (January 9, 2025)** to be included in our auction brochure and ads.
